****REMINDER** 2011 Legislative Interview Materials Available: Building Relationship with Your Legislators!!!**

What: LWVO highly encourages local Leagues to conduct face-to-face interviews with their Ohio legislators at the beginning of each new session of the General Assembly (odd-numbered years). There are two reasons for the interviews.

- They allow local Leagues to establish relationships with newly elected officials and solidify connections with returning legislators in an easy way.
- Second, it is essential that the League build relationships with legislators and promote our advocacy agenda—and local Leagues get first chance at establishing that relationship.

Where is the information Leagues need? The Legislative Interview Packet is on the LWVO website in the Member Area section under [2011 legislative interview materials](#). The packet includes local League assignments, interview questions, and reporting form.

It's that time of year again: please update your membership roster with LWVUS for an accurate member count! The member count (determined by your updates to the LWVUS membership database) will "freeze" on January 31, 2011. This number will determine the amount your League must pay in PMP for FY2011-12. To update your member count, you must update your roster, including the expiration date and status ("inactive" or "active") in each member record. ****REMINDER** Deadline to Transfer Local League Education Funds: June 30, 2011**

We are past the mid-point in our fiscal year and following up on earlier notes, the LWV-Ohio Education Fund will discontinue administering local League education funds (LLEFs) at the end of this fiscal year—June 30, 2011—rather than start charging fees of participating Leagues.

To continue to ensure the local Leagues' ability to easily maintain their education funds, the board has investigated and shared a number of options for transferring administration of your League's education fund to another entity with the presidents and treasurers of the local Leagues. **The LLEFs currently administered by the state Education Fund, must transfer its fund from LWV-Ohio Education Fund before the June 30, 2011, deadline.**
