We will have a day full of wonderful speakers including our keynote speaker, Professor Erin O'Brien. The title of her talk is "Turning Empty into Half Full: Why States Adopt Restrictive Voter Access Policies and the Promising State-level Reforms that Increase Turnout."



League members may remember Dr. O'Brien from the excellent presentation she gave at the LWVUS Convention in Dallas last summer. Dr. O'Brien is Chair and Associate Professor of Political Science at University of Massachusetts Boston as well as co-director of the Boston Chapter of the Scholar Strategy Network. Her research and teaching interests focus on voting access policymaking in the United States, the politics of poverty and social welfare policy, and gender in political participation and representation. She is also a regular commentator on American politics and public policy for outlets including NPR, Christian Science Monitor, Real Clear Politics, New England Cable News (NECN), The Boston Globe, Boston Herald, and SIRIUS Radio's POTUS channel.

All Statehouse Day attendees will have the option of requesting a meeting with their legislator through the LWVO office and can be teamed up for the meeting with a member of the Lobby Corps, if desired. ## Annual Campaign 2015

It's that time again! But this year, we aim to keep our campaign short and sweet. It will begin on March 1st and end March 31st. The State League depends heavily on the support of individual donors to continue our critical work. ## New Developments in Judicial Voter Education & Reform

The League has joined with the Ohio Supreme Court, the Ohio State Bar Association and the Bliss Institute of the University of Akron in an effort to develop a statewide judicial voter guide that will provide information about all judicial candidates in the State. In addition, the Guide, which will be housed on a website at the University of Akron, will provide information about the courts. This information will be available for use in League voter service including Voters' Guides. It is hard to vote intelligently for a judge for a particular court, such as probate or appellate court, without a basic understanding of what these courts do.

In conjunction with this effort, the Bliss Institute conducted a poll of Ohio voters. The poll found that three fifths of registered voters said that the major reason that they didn't vote for judges was because of lack of information about the candidates. A site where this information is readily available should be welcomed, although there will be a challenge to publicize it and make it user friendly. The poll also indicated considerable interest by many Ohioans in considering other ways of selecting judges, suggesting that Ohioans may not be as wedded to judicial elections as some have assumed.

The League has long sought to change the way Ohioans select their judges and the polling results coupled with the growing problem of money has encouraged us to renew our efforts. The ramification of money in politics extends far beyond the judiciary, but it is particularly pernicious when it relates to judges because it undermines their independence in appearance if not in fact.

In February we convened a meeting with interested parties, including the Chief Justice and other representatives of the Supreme Court, the Ohio State Bar Association, the Bliss Institute and various national groups active in judicial reform, including Justice at Stake, the Piper Fund and the Brennan Center.

The upshot of the meeting is that we intend to meet with various stakeholders around the State who might be interested in some aspect of judicial reform, be it appointment retention elections or some of the other alternatives which might improve the current situation, such as a commission to screen judicial candidates, enhanced disclosure coupled with stricter recusal rules, or private financing. Reform will not be accomplished overnight, but we are hopeful that a long term strategic effort can produce results.

## LWVO Supports Redistricting Reform on Fall 2015 Ballot

At its January meeting, the LWVO board discussed the redistricting reform measure (HJR12) that was passed by the legislature in December. The LWVO Board voted to support the redistricting reform proposal that will be on the November 2015 ballot as Issue 1.

The proposal meets many of the criteria in the LWVO position:

- LWVO's position on redistricting calls for a bi-partisan redistricting board. The proposal calls for a redistricting commission made up of the Governor, Auditor, Secretary of State and 2 majority party appointees and 2 minority party appointees. There must be bi-partisan approval of any plan that is to last for the entire decade. This is a big step forward because not only is the commission bi-partisan, but there is a requirement that both parties approve the maps.
- LWVO's position encourages citizen participation. The proposal calls for 3 public hearings around the state to seek input after the commission selects proposed maps and before it makes final selections. It also requires that all meetings be open to the public and that they be broadcast electronically in a medium readily accessible by the general public.
- LWVO's position calls for districts to be compact and follow local political boundaries as much as possible. The proposal strictly requires districts to be within a single county or to be made up of people in counties next to each other. If that isn't possible, the commission must respect municipal, township and ward boundaries. This should produce districts that make more sense to voters who are already familiar with the local political boundaries.

There is bi-partisan support for this proposal. The League is looking forward to working with traditional coalition partners, as well as other supporters of the ballot issue, in educating voters about the way this proposal could give us representatives who better reflect voters' political values.

It should be noted that Issue 1 only addresses how districts are drawn for the Ohio Legislature, not Congress. The League will continue to work for Congressional redistricting.



## From the President's Desk

The League can play a significant role both in informing Ohioans and encouraging discussion of key issues that affect Ohioans. One such issue is public education. Over the years, efforts by the League and others to address problems with the funding of public education in Ohio produced victories in the Court, but regrettably did not translate into solutions to the problems of unequal access to education and inadequate education for many Ohio children. These problems are still with us. Recent years have seen different funding formulas, the expansion of testing, and the explosion of “public” charter schools, with little oversight as to how funds are used or how well Ohio’s children are being educated.

In an effort to foster discussion of the issues facing public education today, Leagues around the State, in conjunction with the Akron Beacon Journal and journalism students, will be hosting public forums on education. The forums will first address the purpose of education and what should be the role of government. We will then consider that we mean by public education – from traditional schools to vocational schools to charter schools, etc., and who should set the standards. And finally, we will look at what expectations and accountability should apply to all the different types of schools that receive public money. These forums will be conducted by trained volunteer League facilitators.

It is our hope that these forums will be publicized widely and will be attended by a large spectrum of the community offering an opportunity for local Leagues to reach new audiences. And we envision that many local Leagues may consider this merely the first step in an effort to educate members and their communities about the problems facing education in Ohio. We hope to have the first forums in the spring with additional forums in the fall. If your League is not yet involved and is interested in participating, it is not too late. Of course, our efforts are not confined to discussion. The League is reviewing the Governor’s budget proposal and we plan to use our positions on education to lobby for improvements. This is one of our priority areas and will get attention over the next few months. We also have a small task force considering the specific steps that the League can take using its existing education position to advocate effectively to address problems with charter schools in Ohio.

If advocacy is your passion or you just want to learn more about what is going on in the legislature, consider joining the Lobby Lunch calls from 12 to 1 on the second and fourth Tuesday of the month. Lobby Lunch has met in Columbus for years, but we have recently recognized that few Leaguers can attend an hour meeting in Columbus, Ohio. By making Lobby Lunch a phone call rather than an in person meeting, it is now open to all League members from Marietta to Toledo. Please call the office if you want to be notified of upcoming Lobby Lunches.

## Executive Director's Column: Celebrating 95 Years of the League of Women Voters

On February 14, 1920, the League of Women Voters was founded by Carrie Chapman Catt during National American Woman Suffrage Association convention. Six months later the 19th amendment to the U.S. Constitution was ratified, giving women the right to vote after a 72-year struggle. The Ohio League of Women Voters will also celebrate our 95<sup>th</sup> birthday this year, on May 5.

Throughout the year, we will highlight some of League's more notable accomplishments.

### Here are some fun facts about the League's first 95 years

- The League was founded by suffragist Carrie Chapman Catt and was charged with “finish[ing] the fight” to ensure that every eligible voter has free and fair access to the polls.
- Another of the League's early leaders was Eleanor Roosevelt, who helped establish the first policy agenda. As the League's Vice President of Legislative Affairs, she lobbied for reforms in Congress and worked tirelessly to strengthen women's role in politics, helping mobilize women voters through the League's nonpartisan training and lobbying work. “I've always found that the best workers in a political party frequently are graduates of the League of Women Voters,” she wrote in 1953.
- The League's first major advocacy success was passage of the Sheppard-Towner Act of 1921, a groundbreaking law providing federal funding for maternity and child care.
- Following World War II, the League helped lead the effort to establish the United Nations. The League of Women Voters was one of the first organizations in the country officially recognized by the United Nations as a non-governmental organization, and we maintain an official observer U.N. status today.
- In 1952, the League joined NBC and Life magazine in sponsoring the first-ever televised U.S. presidential debate. We served as the official presidential debate sponsor from 1976-1984.
- McCarthyism and the witch hunt period of the 1950s inspired the League to help educate Americans on their individual rights and liberties as guaranteed by the Constitution. LWVUS President Percy Maxim Lee testified before Congress in 1955 against Senator Joseph McCarthy's abuse of congressional investigative powers. “I believe tolerance and respect for the opinions of others is being jeopardized by men and women whose instincts are worthily patriotic, but whose minds are apparently unwilling to accept the necessity for dissent within a democracy.”
- Between 1950 and 1970, the League increased its effectiveness in regard to both public education and advocacy, prompting Senator George Aiken to remark, “Only 135,000 of them? I thought there were millions.”
